

Michael Allegetti, Board Director & Chairman

Michael serves as the Principal of the Hudson Square Group, where he provides advisory and consulting services to early-stage start-ups including Amevida, Prophetic AI, Shur, and Taza, as well as private equity firms looking to advance deals in industries related to waste and recycling, and public service innovation. Prior to this venture, he worked for six and half years as Chief Strategy Officer for Rubicon Technologies, Inc. (NYSE: RBT), where he served as a member of the founding Executive Leadership Team that helped to take the company public in August 2022. At Rubicon, the world's largest digital platform for waste, recycling and smart city solutions, he created and led the company's rapidly growing RUBICONSmartCity™ software business, while also overseeing all public policy, corporate communications, marketing, and environmental operations company-wide.

Prior to joining Rubicon, Michael oversaw public policy for Uber Technologies Inc. in the company's largest global market, New York City. He has also served as a senior advisor to various non-profit in the environmental and energy space. Most notably, he led public policy for the Manhattan Institute for Policy Research as Vice President, working for three years on the ground in the City of Detroit to help revamp the city's police department and seed economic development initiatives. Michael was also formerly the Political & Public Policy Analyst for UBS (NYSE: UBS), and midway through his career, he launched a highly competitive campaign for the U.S. House of Representatives in New York's 13th Congressional District.

Michael holds a Bachelor's Degree in History from Boston College and a Master's Degree in Public Policy from Harvard University's John F. Kennedy School of Government. He has served as an Advisor to numerous technology start-ups including the Citizen App (aka, SpOn Inc.), a start-up that alerts citizens in real-time to crimes and other emergencies in their vicinity. Michael is a member of the Board of Directors of Guardian Revival, a national non-profit organization that provides direct support to help rehabilitate veterans and former first responders; is also a member of the Board of Directors of the Pocono Mountains Music Festival; and is a Fellow and former U.S. Chair of the British American Project. Karl Weiler, Board Director & Secretary

Karl Weiler is the Chairman Emeritus of Weiler Abrasives Group. He graduated from Hofstra University in 1960, having earned a BBA in Business and an Infantry Officer Reserve Commission in the United States Army. He graduated from the Infantry School at Fort Benning Georgia in 1961. During his 7-1/2 years of active and reserve duty, he graduated from the U.S. Army Armor School at Fort Knox, Kentucky and was discharged in 1968 from the Army Reserves with the rank of Captain Armor.

He joined Weiler Corporation (a business started by his father in 1944 in a converted chicken coop in Franklin Square N.Y.) in 1962 when the company employed approximately 25 people. Since then, he has held various positions within the organization and became President and Chief Executive Officer in 1972, and Chairman in 1998. Karl is today the Chairman Emeritus of the Weiler Abrasives Group.

The Weiler Abrasive Group is today a leading global manufacturer and marketer of Industrial Brushes and Abrasives selling in over 80 Countries. The company employs over 1,200 people with operations in Cresco, Pennsylvania, Brazil, Mexico, Germany and Slovenia.

Karl has served on numerous profit and nonprofit boards. He currently serves on the boards of the Pocono Mountain Municipal Airport Authority and the Barrett Economic Development Corporation. He is a member of the Young Presidents Organization YPO Gold.

Karl and his wife, Ann (also a Hofstra graduate) have three sons - Richard, who is a Design Engineer at Square D Corporation in Raleigh NC., Chris, who is Executive Chairman of the Weiler Abrasives Group, and James who teaches Industrial Design at East Stroudsburg University. Karl and his wife Ann have six grandchildren. Karl's hobbies include golf, collecting cars, and flying. During his flying career Karl held a commercial multi engine instrument pilot's license.

David Christine, Board Director & Treasurer

On January 1, 2024, E. David Christine, Jr. officially retired as the longest-serving District Attorney in the history of Monroe County, having served six terms in office. Subsequently, he was appointed by current District Attorney Mike Mancuso to the position of District Attorney Emeritus. As District Attorney Emeritus, David will continue to use his experience, professionalism, and legal expertise to mentor new Assistant District Attorneys.

David was born in East Stroudsburg, Pennsylvania and is a seventh-generation descendant of Philip Bossard, the first European pioneer to settle in Cherry Valley in 1745. David grew up on the family farm located only a few miles away from the Bossard homestead. Born into a family with a proud reputation for public and community service, David is the son and namesake of the late Elmer D. Christine, Sr., Esquire and the late Dee Gregory Christine. Elmer D. Christine, Sr. served as District Attorney of Monroe County from 1952 through 1955. One of the longest serving attorneys in the history of Monroe County, Elmer Christine held the position of member of the Monroe County Bar Association for 63 years at the time of his death in 2004.

A dedicated volunteer for many community and charitable organizations, David's mother volunteered at Pocono Medical Center for more than 50 years. His brother, Greg, previously served one term as a Monroe County Commissioner, and also served the citizens of Monroe County as the County Administrator. During his tenure as District Attorney, David resided in Stroudsburg with his wife, Lori J. Cerato, Esq. Post-retirement, the couple has moved to Buck Hill Falls.

David is a 1975 graduate of Stroudsburg High School, graduated from Lafayette College with a bachelor's degree in government & law in 1979, and then graduated as a Dean's Scholar from the Southwestern University School of Law in Los Angeles, California in 1981. He then returned to Cherry Valley to fulfill his lifelong dream of practicing law with his father.

David first began working as a prosecutor in 1982, for then-District Attorney James F. Marsh, who became his mentor in the field of criminal prosecution. When he succeeded Attorney Marsh as the District Attorney in 1988, Christine, at age 30, was the youngest District Attorney ever elected in Monroe County. In addition to his career as a criminal prosecutor, David practiced civil law with his father for 23 years at the law firm of Christine & Christine, located in East Stroudsburg, Pennsylvania. David has been a

member of the bar of the Commonwealth of Pennsylvania and Monroe County for more than 44 years.

Prior to serving as District Attorney, David held the role of Solicitor for the Tobyhanna Township Board of Supervisors, the Stroud Township Zoning Hearing Board, and the Stroud Area Regional Police Commission. He also served as specially appointed Solicitor for the Board of Supervisors of Stroud Township, Smithfield Township and Pocono Township. David is a past Board Member of the Center for Developmental Disabilities, the Monroe County Industrial Development Authority, and was a Special Public Defender by Appointment of President Judges James R. Marsh and Ronald E. Vican.

Elliot Dee, Board Director
